

SPECIAL MEASURES FOR THE AGM

CHARACTERISTICS OF GEM

PROPOSED GRANT OF GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES; REAPPOINTMENT AND ELECTION OF DIRECTORS; REAPPOINTMENT OF AUDITOR AND NOTICE OF ANNUAL GENERAL MEETING

INTRODUCTION

The primary purpose of this circular is to provide you with information regarding the resolutions to be proposed at the AGM and to give you notice of the AGM. Resolutions to be proposed at the AGM include but not limited to ordinary resolutions relating to the proposed grant of the Issue Mandate, the Repurchase Mandate and the Extension Mandate, and the Reappointment and Election of Directors.

GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES

At the last annual general meeting ("AGM") of the Company held on 6 Feb 2020, general mandate was granted to the Directors to issue new Shares and repurchase Shares. The said general mandate will expire at the conclusion of the forthcoming AGM. The Board shall review the market situation from time to time and exercise the general mandate to issue Shares for fund raising activities if and when appropriate. The Board believes that the exercise of the general mandate to issue Shares (Issue Mandate) is in the best interests of the Company and the Shareholders as a whole by maintaining the financial flexibility for the future business development of the Group. Resolutions set out as the ordinary resolution numbers 5 and 6 in the Notice will be proposed at the AGM to grant fresh mandates to the Directors: (i) to allot, issue and deal with Shares of up to 20% of the total number of Shares in issue as at the date of passing resolution granting the Issue Mandate as resolution number 5 set out in the Notice. Based on 2,937,537,811 Shares in issue as at the Latest Practicable Date and assuming no further Shares are issued and no Shares are repurchased after the Latest Practicable Date and up to the date of the AGM, the Directors will be able to allot, issue and deal with up to a total of 587,507,562 Shares if the Issue Mandate is granted at the AGM; and (ii) to repurchase Shares not exceeding 10% of the total number of Shares in issue as at the date of passing of resolution number 6 set out in the Notice granting the Repurchase Mandate. Based on 2,937,537,811 Shares in issue as at the Latest Practicable Date and assuming no further Shares are issued and no Shares are repurchased after the Latest Practicable Date and up to the date of the AGM, the Directors will be able to repurchase for up to a total of 293,753,781 fully paid Shares if the Repurchase Mandate is granted at the AGM.

To further explain the total number of Shares in issue of the Company and provide information in relation to the subscription agreement entered between East Asia Oil Engineering Group Limited (as "Subscriber") on 28 June 2020, pursuant to which the Subscriber has agreed to subscribe for and the Company has agreed to issue the convertible bonds in the principal amount of HK\$100,000,000 at the initial conversion price of HK\$0.180 per conversion share. Based on the initial conversion price of HK\$0.180 per conversion shares will be allotted and issued upon exercise of the conversion rights attaching to the convertible bonds in full. The conversion shares upon exercise of the conversion rights attached to the convertible bonds are to be issued under the general mandate granted to the Directors at the annual general meeting of the Company held on 6 February 2020. Completion of the subscription is conditional upon, among other things, the listing of and permission to deal in the conversion shares being granted by the listing committee of the Stock Exchange. If the Subscriber is approved to exercise all or part of the Company as at the date of the AGM will be increased by such additional number of Shares actually issued and allotted to the Subscriber upon its exercise of the conversion rights attaching to the conversion rights attaching to the convertible bonds for the convertible bonds and the convertible bonds prior to the AGM, the total number of Shares in issue of the Company as at the date of the AGM will be increased by such additional number of Shares actually issued and allotted to the Subscriber upon its exercise of the conversion rights attaching to the convertible bonds after the Latest Practicable Date and up to the date of the AGM.

The Issue Mandate and the Repurchase Mandate will remain in effect until whichever is the earliest of (i) the date of the next annual general meeting of the Company; (ii) the date by which the next annual general meeting is required to be held by the Articles of Association or the Companies Ordinance or the GEM Listing Rules; and (iii) the date upon which such an authority is revoked or varied by an ordinary resolution of the Shareholders in a general meeting. In addition, a separate ordinary resolution will further be proposed for extending the Issue Mandate authorising the Directors to the effect that any Shares repurchased under the Repurchase Mandate will be added to the total number of Shares which may be allotted and issued under the Issue Mandate. An explanatory statement required under Rule 13.08 of the GEM Listing Rules to be sent to the Shareholders in connection with the Repurchase Mandate is set out in the Appendix I to this circular. The explanatory statement contains all information reasonably necessary to enable the Shareholders to make an informed decision on whether to vote for or against the relevant proposed ordinary resolution for the grant of the Repurchase Mandate at the AGM.

REAPPOINTMENT AND ELECTION OF DIRECTORS

Pursuant to Article 83(3) of the Company's Articles, any Director appointed by the Board to fill a casual vacancy shall hold office until the first AGM of the Company after his appointment and be subject to reappointment and election at such meeting and any Director appointed by the Board as an addition to the existing Board shall hold office only until the next following AGM of the Company and shall then be eligible for reappointment and election.

By virtue of articles 84 (1) of the Company's Articles, one-third of the Directors for the time being (or, if their number is not a multiple of three (3), the number nearest to but not less than one-third) shall retire from office by rotation at each AGM, provided that every Director shall be subject to retirement at an AGM at least once every three years. As such, Mr. LAI Chun Liang, Mr. KWAN King Chi George, Ms. XIE Qun and Mr. PAI Hsi-ping will retire by rotation at the forthcoming AGM, and being eligible, will offer themselves for reappointment and election.

The biographical details of the Directors proposed to be reappointed and elected at the AGM are set out in the Appendix II to this circular.

ANNUAL GENERAL MEETING

- At the AGM, ordinary resolutions will be proposed to approve, among other matters, the following:
- (a) the grant of the Issue Mandate, the Repurchase Mandate and the Extension Mandate; and
- (b) the reappointment and election of Directors.

Whether or not you are able to attend the AGM in person, you are requested to complete and return the accompanying form of proxy in accordance with the instructions printed thereon as soon as possible and in any event not later than 48 hours before the time for the AGM or any adjournment thereof to the branch share registrar of the Company in Hong Kong, Tricor Standard Limited, at 54th Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong. Completion and return of the form of proxy will not preclude you from attending and voting in person at the AGM or any adjournment thereof should you so wish.

Pursuant to Rule 17.47 (4) of the GEM Listing Rules, all the resolutions proposed to be approved at a general meeting must be taken by poll. An announcement will be made by the Company after the AGM on the results of the AGM.

RESPONSIBILITY STATEMENT

This circular, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the GEM Listing Rules for the purpose of giving information with regard to the Company. The Directors, having made all reasonable enquiries, confirm that, to the best of their knowledge and belief: (1) the information contained in this circular is accurate and complete in all material respects and not misleading; (2) there are no other matters the omission of which would make any statement in this circular misleading; and (3) all opinions expressed in this circular have been arrived at after due and careful consideration and are founded on bases and assumptions that are fair and reasonable.

RECOMMENDATION

The Directors believe that the proposed grant of the Issue Mandate, the Repurchase Mandate and the Extension Mandate and the reappointment and election of Directors are in the best interests of the Company and the Shareholders as a whole.

The Directors believe that an exercise of the Issue Mandate will enable the Company to take advantage of market conditions to raise additional capital for the Company.

The Repurchase Mandate may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or earnings per Share and will only be exercised when the Directors believe that repurchases of Shares will benefit the Company and the Shareholders.

Taking into account the current working capital position of the Company, the Directors consider that, if the Repurchase Mandate was to be exercised in full, it might have a material adverse effect on the working capital and/or the gearing position of the Company as compared with the position that as at 31 December 2019, being the date of its latest published audited financial statements, however, the Directors do not intend to make any repurchases to such an extent as would, in the circumstances, have a material adverse impact on the working capital requirements or the gearing position of the Company which in the opinion of the Directors are from time to time appropriate for the Company.

Accordingly, the Directors recommend the Shareholders to vote in favour of the ordinary resolutions approving the grant of the Issue Mandate, the Repurchase Mandate and the Extension Mandate and the reappointment and election of Directors at the AGM.

GENERAL INFORMATION

Your attention is drawn to the additional information set out in the appendices to this circular.

PRECAUTIONS IN LIGHT OF COVID-19 PANDEMIC

At the time of issuing this circular, many countries and regions around the world including Hong Kong are still devoting vigorous efforts to contain the COVID-19 pandemic. The situation is evolving and it is hard to predict when the crisis will end.

The health and safety of our Shareholders and staff are our top priority as we plan for the AGM. It is important that we continue to stay alert and help prevent the spread of the disease, and Shareholders are reminded to consider for themselves whether they should attend the AGM in person. The health risks posed by large scale gathering should not be underestimated.

In order to protect attending Shareholders and staff of the Company from the risk of infection, the Company will implement the following precautionary measures at the AGM:

- Compulsory temperature checks for every attending Shareholder, proxy or other attendance at the entrance to the building where the AGM will be held. Any person with a fever or is unwell may be denied entry into the meeting venue.
- Any person who does not comply with the precautionary measures or is subject to any Hong Kong SAR Government prescribed quarantine may be denied entry into the meeting venue. Health declaration may be required.
- All attendees have to wear face masks within the meeting venue and throughout the AGM.
- There will be no distribution of gifts and no refreshments will be served.
- Appropriate seating spacing will be implemented to ensure safe distancing among attendees.

The Company also reminds Shareholders that attendance at the AGM in person is not necessary for the purpose of exercising voting rights. Shareholders may consider appointing the chairman of the AGM as their proxy to vote on the relevant resolutions(s) at the meeting as an alternative to attending the AGM in person.

The Company will watch out for updated guidelines and requirements from the Hong Kong SAR Government. In the event that the AGM has to be rescheduled due to the latest development of the COVID-19 pandemic, Shareholders will be notified of the revised date in the same manner as they would for a black rainstorm warning as set out in the notice of AGM.

APPENDIX I EXPLANATORY STATEMENT FOR THE REPURCHASE MANDATE

This Appendix I serves as an explanatory statement required to be sent to all Shareholders pursuant to Rule 13.08 and other relevant provisions of the GEM Listing Rules in connection with the Repurchase Mandate.

1. GEM LISTING RULES RELATING TO THE REPURCHASE OF SHARES

The GEM Listing Rules permit companies whose primary listing is on GEM to repurchase their shares on the GEM and any other stock exchange on which the securities of the company are listed and such exchange as recognised by the Securities and Futures Commission of Hong Kong subject to certain restrictions. Among such restrictions, the GEM Listing Rules provide that the shares of such company must be fully paid up and all repurchases of shares by such company must be approved in advance by an ordinary resolution of shareholders, either by way of a general repurchase mandate or by specific approval of a particular transaction.

2. SHARE CAPITAL

As at Latest Practicable Date, there were a total of 2,937,537,811 Shares in issue.

Subject to the passing of the proposed resolution granting the Repurchase Mandate and on the basis that no further Shares are issued or repurchased prior to the AGM, the Company will be allowed under the Repurchase Mandate to repurchase a maximum of 293,753,781 Shares.

3. REASONS FOR THE REPURCHASE

The Directors believe that the Repurchase Mandate is in the best interests of the Company and the Shareholders. Repurchases of Shares will only be made when the Directors believe that such repurchases will benefit the Company and the Shareholders. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value of the Company and/or earnings per Share.

4. FUNDING AND EFFECT OF REPURCHASES

Repurchases made pursuant to the Repurchase Mandate will be funded out of funds legally available for the purpose in accordance with the Company's memorandum of association, the Articles, the Companies Law and other applicable laws of the Cayman Islands. A listed company may not repurchase its own securities on GEM for a consideration other than cash or for settlement otherwise than in accordance with the trading rules of the Stock Exchange. Under the Companies Law, repurchases by the Company may only be made out of profits of the Company or out of the proceeds of a fresh issue of Shares made for the purpose, or, if so authorised by the Articles and subject to the provisions of the Companies Law, out of capital. Any premium payable on a redemption or purchase over the par value of the Shares to be purchased must be provided for out of profits of the Company or out of the Company's share premium account, or, if so authorised by the Articles and subject to the provisions of the company by the Articles and subject to the provisions of the Company by the Articles and subject to the provisions of the Company by the Articles and subject to the provisions of the Company by the Articles and subject to the provisions of the Company by the Articles and subject to the provisions of the Company by the Articles and subject to the provisions of the Companies Law, out of capital.

5. THE TAKEOVERS CODE AND MINIMUM PUBLIC HOLDING

If a Shareholder's proportionate interest in the voting rights of the Company increases on the Company exercising its powers to repurchase Shares pursuant to the Repurchase Mandate, such increase will be treated as an acquisition for the purposes of Rule 32 of the Hong Kong Code on Takeovers and Mergers ("**Takeovers Code**"). As a result, a Shareholder or group of Shareholders acting in concert (as defined in the Takeovers Code) could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rules 26 and 32 of the Takeovers Code.

As at the Latest Practicable Date, according to the register of members kept by the Company pursuant to section 336 of the SFO and so far as was known to, or could be ascertained after reasonable enquiry by the Directors, Mr. Lam Nam and Silver Star Enterprises Holdings Inc. together control 65.54% interest in the issued Share. Silver Star Enterprises Holdings Inc. is wholly owned by Mr. Lam Nam.

APPENDIX I EXPLANATORY STATEMENT FOR THE REPURCHASE MANDATE

Assuming Mr. Lam Nam and Silver Star Enterprises Holdings Inc. will not dispose of their interests in the Shares nor will they acquire additional Shares, if the Repurchase Mandate was exercised in full, the percentage shareholding of Mr. Lam Nam and Silver Star Enterprises Holdings Inc. would be increased to approximately 72.83% interest in the issued Share.

On the basis of the shareholding interests of Mr. Lam Nam and Silver Star Enterprises Holdings Inc. in the Company, an exercise of the Repurchase Mandate in full would not result in it becoming obliged to make a mandatory offer under Rule 26 of the Takeovers Code. In the view of this, an exercise of the Repurchase Mandate in full would not result in them becoming obliged to make a mandatory offer under Rule 26 of the Takeovers Code. Save as disclosed above, the Directors are not aware of any consequence which may arise under the Takeovers Code as a consequence of any purchases made pursuant to the Repurchase Mandate.

Save as disclosed above, the Directors are not aware of any consequences, which may arise under the Takeovers Code as a result of any repurchases to be made under the Repurchase Mandate.

The Directors have no intention to exercise the Repurchase Mandate to such an extent that would result in the number of Shares in the hands of public falling below the prescribed minimum percentage of 25% of the total number of Shares in issue.

6. SHARE REPURCHASE MADE BY THE COMPANY

The Company has not purchased any of the Shares (whether on GEM or otherwise) in the six months immediately preceding the Latest Practicable Date.

7. UNDERTAKING OF DIRECTORS

The Directors have undertaken to the Stock Exchange that they will only exercise the power of the Company to make repurchases pursuant to the Repurchase Mandate in accordance with the GEM Listing Rules and the applicable laws of the Cayman Islands.

8. INTENTION TO SELL SHARES

None of the Directors nor, to the best of their knowledge having made all reasonable enquiries, any of their associates have any present intention to sell any Shares to the Company if the Repurchase Mandate is approved by the Shareholders.

PARTICULARS OF DIRECTORS FOR REAPPOINTMENT AND ELECTION

The biographical details of the Directors eligible for reappointment and election at the AGM are set out below:

Mr. LAI Chun Liang, aged 55, joined Polyard Petroleum International Company Limited, a wholly-owned subsidiary of the Company as an Executive Vice President in 2003. He was appointed as the Chief Operating Officer of the Group in September 2009, the Chief Executive Officer in June 2010, and an Executive Director of the Company in May 2012.

Mr. KWAN King Chi George, aged 70, holds a Master Degree of Science (Finance) with Honours from the National University of Ireland and a Bachelor Degree of Business Administration from the Royal Melbourne Institute of Technology. He also obtained a Doctoral Degree of History from the Wuhan University in 2016. He has over 40 years of experience in the profession of banking and finance, accounting, investment and business management. He had been the Assistant General Manager and Chief Operation Officer of ICBC (Asia) Limited, the Senior Vice President and Head of Operations of International Bank of Asia Limited (now Fubon Bank (Hong Kong) Limited), and the Senior Manager in the International Banking Department of Bank of Hawaii. Mr. KWAN is a member of The Hong Kong Institute of Directors. He was appointed as an independent non-executive director of the Company in November 2014.

Ms. XIE Qun, aged 55, holds a Ph.D. Degree in English Language of The Chinese University of Hong Kong and a Master of Arts Degree and a Bachelor of Arts Degree in English Language of Central China Normal University. She has over 25 years of experience in the profession of education. Ms. XIE was appointed as an independent non-executive director of the Company in September 2013.

Mr. PAI Hsi-ping, aged 59, holds a bachelor degree in international trade from the National Chen-Chi University, Taiwan. He has over 21 years of working experience in management and is currently the Chief Executive Officer of a consultancy company in Taiwan. Besides, he previously held directorship and other major appointment in three listed public companies in Taiwan. He is currently the Director of Taiyen Biotech Company Limited. In addition, he was the Director of Formosa Plastics Corporation during the period from June 2006 to March 2008 and the Chairman of Far East Air Transport Corporation for the period from April 2008 to May 2008. Mr. PAI was appointed as an independent non-executive director of the Company in July 2009.
